Operations Manager Martin took the floor noting that the spring clean-up service is now underway and further that staff anticipate that the Management Centre sites will see the program heavily used and that all are prepared to manage the anticipated increase in the volume of materials passing through operations. Mr. Martin further noted that the Management Centre sites proved to be very busy over the Easter long weekend.

Agenda Item No. 7 - Communications Manager Monthly Report

Communications Manager Garrett took the floor to present his report, as circulated and attached to these minutes.

A discussion arose with it being the general consensus that litter around the Valley Region appears to have increased over the past few years. It was noted that when litter occurs along 100 series highways, it is the Department of Transportation that generally tackles cleaning up the area due to serious safety concerns. It was further noted that disposable coffee cups continue to be heavily found in littered areas.

Agenda Item No. 8 - Regional Coordinators and Regional Chairs Report

Communications Manager Garrett took the floor to present the Regional Chairs and Regional Coordinator Report to the Authority, referencing the 2015-2016 Provincial Datacall presentation, both as circulated and attached to these minutes. The Datacall is a collection of solid waste financial and volume-based data collected from all municipalities in Nova Scotia annually.

A discussion arose regarding the value of the datacall findings with it being noted that staff have requested that the statistical information be re-organized on a regional basis to allow for more clarity in comparing regions. At present, some statistics are provided based on regional information with other statistics based on individual municipality activity levels. It was stressed that based on the datacall findings; comparatively, the Valley Region continues to do very well. A discussion also arose regarding packaging with it being the consensus that it is critically important to continue to pressure the provincial government to move forward with Extended Producer Responsibility programs. It was indicated that the results of the datacall can be brought forward again once the re-organized regional information is available.

Agenda Item No. 12 – Correspondence

Mr. Hirtle took the floor noting a presentation that the Council of the Municipality of the County of Kings had recently received regarding the upcoming Canada 150 Event being held at Grand Pre. Representatives of the event are seeking sponsorship in any possible way and specifically noted Kings Transit and Valley Waste as potential partners. An e-mail dated April 18, 2017 from Mr. Hirtle to Communications Manager Garrett regarding the matter is attached to these minutes. It was noted that

while Valley Waste would be unable to offer financial sponsorship, staff would be pleased to help in other ways especially in event greening and the provision of sorting stations. Mr. Hirtle noted that Mr. Garrett will be provided with event organizer contact information.

Related to correspondence, Chair Bustin noted that she continues to await information from Annapolis County regarding its position on the budget and upon a quick round table check, it was noted that a number of partner municipalities have passed the draft 2017-2018 Operating and Capital Budget while other partners have (also or exclusively) approved an operating plan for the Authority based on the 2016-2017 budget.

It was also noted that a number of partner municipalities have or are in the process of passing what they perceive to be a necessary motion in order to confirm that the Town of Annapolis Royal is a fully participating municipal partner. Solicitor Coyle noted that he has not seen the wording of the proposed amendment to the Intermunicipal Services Agreement.

Agenda Item No. 10 - Next Meeting

The next meeting of the Valley Region Solid Waste-Resource Management Authority will be held on Wednesday, May 17, 2017, beginning at 9:00am in keeping with the normal meeting schedule. It was noted that the Northridge Farms and Western Management Centre Orientation tours will take place following the June Authority meeting.
