## Agenda Item No. 1 - Call To Order

Chair, John Kinsella welcomed everyone and called the meeting to order at 3:06 pm. Chair Kinsella noted that the purpose of the special meeting is to ratify recommendations for the reallocation of funds for the purpose of dealing with costs incurred from the cessation of the collection and the withdrawal of Annapolis County; for example: green carts.

## Discussion:

Interim General Manager Cathie Osborne explained (through conference call) the costs associated with Annapolis County withdrawing from the Authority was not budgeted; however, staff are keeping track of the costs; including the picking up of the green carts in Annapolis County. The cost for providing services to Annapolis County is in the budget but these costs are not being realized due to the cessation of services. In keeping with the terms of the IMSA, GM Osborne believes it is necessary to put forward a supplementary budget report to request the reallocation of funds budgeted for service delivery towards withdrawal associated expenditures. A discussion ensued as to whether or not this should be termed a Supplementary Budget or a reallocation of funds. GM Osborne felt it should be termed a Supplementary Budget because not only is this the language of the Inter-municipal Service Agreement but also because the Authority Board goes through the budget line for line and this is not a listed item. Following a brief discussion the following motion was made: MOVED BY BRIAN HIRTLE AND SECONDED BY WENDY ELLIOT THAT THE VALLEY REGION SOLID WASTE-RESOURCE MANAGEMENT AUTHORITY RECOMMEND TO THEIR PARTIES THE CONSIDERATION AND APPROVAL OF A SUPPLEMENTARY BUDGET TO REALLOCATE FUNDS TO COVER THE ADDITIONAL COST ASSOCIATED WITH THE SERVICE CESSATION TO ANNAPOLIS COUNTY.
