#### Agenda Item No. 1 – Call To Order

Chair Corkum welcomed everyone and called the meeting to order at 10:00am. Round table introductions were made in person and online.

# Agenda Item No. 2 - New Intermunicipal Services Agreement

Chair Corkum invited Dan McDougall to present information based on the document, *Agenda Item 2 Request for Decision New Intermunicipal Services Agreement*, which was circulated as part of the meeting package. Mr. McDougall first referred to the Request for Decision document noting that a correction to Schedule C in the Valley Region Solid Waste-Resource Management Authority Agreement will form part of the final package. Mr. McDougall then provided a comprehensive presentation, as attached to these minutes, addressing the key issues within the Request for Decision document.

To enable decision making by the Parties, Mr. McDougall explained the rationale used during the decision making process with the CAO Committee to develop the new Valley Regional Services Intermunicipal Services Agreement and the attached Intermunicipal Services Agreements for the Valley Region Solid Waste-Resource Management Authority and the Kings Transit Authority. The presentation provided an overview of the proposed governance structure, the current and proposed Agreements, the current and proposed funding fomulas and finally the recommendations.

In response to the question, if a member party wishes to implement a supplementary service, Board approval is not required as long as the service operates independently and does not impact KTA ridership or the funding formula.

In response to the question, the structure of solid waste tipping fees may be reviewed in the future to ensure industrial, commercial and institutional customers are not being subsidized by the residential tax base. These fees are determined not only by financial and operational factors but also by philosophical considerations designed to encourage recycling.

In response to the question, if a member party offers a promotional free ridership period, a cost has been calculated to ensure that the member party covers the lost revenue for the Kings Transit Authority.

In response to the request, Mr. McDougall noted that the presentation will be shared with Participating Party Chief Administrative Officers for use with their respective Councils.

**On MOTION** by Warden Gregory, seconded by Mayor Trinacty, that the Board of Directors recommend to the Council of the County of Kings, Town of Wolfville, Town of Kentville, Town of Berwick, County of Annapolis, Town of Middleton, Town of Annapolis Royal, and District of Digby the approval of the Valley Regional Services Agreement as tabled at the June 11, 2025 Board meeting. **Motion carried.** 

**On MOTION** by Mayor Zebian, seconded by Mayor Trinacty, that the Board of Directors recommend to the Council of the County of Kings, Town of Wolfville, Town of Kentville, Town of Berwick, County of Annapolis, Town of Middleton, and Town of Annapolis Royal approve the amended and restated Valley Waste Agreement as tabled at the June 11, 2025 Board meeting.; **Motion carried.** 

**On MOTION** by Warden Gregory, seconded by Andrew Zebian, that the Board of Directors recommend to the Council of the County of Kings, Town of Wolfville, Town of Kentville, Town of Berwick, County of Annapolis, Town of Middleton, and District of Digby approve the amended and restated Kings Transit Authority Agreement as tabled at the June 11, 2025 Board meeting. **Motion carried.** 

**On MOTION** by Mayor Smith, seconded by Mayor Trinacty, that the Board of Directors recommend a Joint Special Council meeting of the parties be held on June 23, 2025, at 7:00pm for consideration and approval of the recommended agreements. **Motion carried.**
